

# CANANDAIGUA SAWBELLIES ANNUAL OPEN WATER SWIM

## A Competitive One-Half, One & Two Mile Open Water Swim and Picnic!!

**DATE/TIME:** July 19, 2008, Saturday at 8:30 am, Warm Up at 7:30 am

**CHIP TIMING:** Each swimmer will be given a timing chip to wear on the ankle during the race to provide accurate times and finish places. Results will be available almost immediately.

**LOCATION:** Canandaigua, New York, Kershaw Park, Lakeshore Drive, North End of Canandaigua Lake  
New York State Thruway Exit 44, South 8 miles, straight to Kershaw Park

**ELIGIBILITY:** Open to all USMS and CASA registered swimmers 18 and older as of July 19, 2008.  
Annual USMS registration will be available at the beach for \$30.00 and single event USMS for \$10.

**CONDITIONS:** Since the safety of swimmers is of prime concern. The swimming event may be delayed or canceled due to bad weather. The Meet Director, Niagara Open Water Director and Ontario County Sheriff will make this decision. There will be no refund.

**ENTRY FEE:** \$15.00 Includes picnic and refreshments. \$20.00 After July 14, 2008. Awards for 1st, 2nd and 3<sup>rd</sup> place finisher, for each age group in each event. Free parking.

**SCHEDULE:** Registration 7:30-8:15 am, 8:15 am Mandatory Meeting for all Swimmers,  
8:30 am start of 2-mile swim, 8:40 am start of 1-mile swim, and 8:50 am start of ½ mile swim. USA Youth Competition will follow completion of USMS meet (approximately 9:40 am). Picnic!!!!

**RULES:** The USMS Long Distance Rules as outlined in part 3 of the 2008 USMS Rule Book shall govern the events.

**COURSE:** Straight out and back one loop is 1 mile in distance, twice around for the Two Mile Swim, half way out and back for ½ mile swim. The Ontario County Sheriff will patrol the perimeter of the course.
